ROADS (WORKS, USE AND COMPENSATION) ORDINANCE (Chapter 370)

TAKE NOTICE that under powers delegated by the Chief Executive, the Permanent Secretary for Transport and Housing (Transport) has ordered under section 17(1)(b) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) ('the Ordinance') to reclaim the Government foreshore and sea-bed within the limit of works area as shown on Plans Nos. 209506/GZ/202 and 209506/GZ/203 ('the Plans') and described in the scheme annexed thereto, and as amended by the amendment scheme. The Plans and scheme were referred to in G.N. 2568 published on 10 May 2013 and 16 May 2013. The amendment scheme was referred to in G.N. 1602 published on 21 March 2014 and 28 March 2014. The Permanent Secretary for Transport and Housing (Transport) has further declared under section 17(1)(c) of the Ordinance that as from 27 August 2018, all public or private rights in, upon, under or over the Government foreshore and sea-bed to be reclaimed, shall be extinguished.

The works to be carried out in association with this reclamation mainly involve the foundation works of the elevated road at the proposed Cross Bay Link and associated works.

This notice will be affixed near the affected Government foreshore and sea-bed on 17 August 2018.

Any person entitled to compensation under the Ordinance may serve upon the Secretary for Transport and Housing a written claim, which can be submitted via one of the following means, before the expiration of one year from the date of closure, extinction, modification or restriction:—
